### \*Terms & Conditions Governing the Academic Scholarship Policy (ISC):

1. If a student is extended/offered more than one concession/scholarship, the highest applicable amount will be considered. Only one concession/scholarship from the various categories can be availed in any one academic year. No two concessions/scholarships can be availed/combined together.
2. The scholarship amount is strictly restricted/calculated on a pro-rata basis only on the Annual Tuition Fee as per the Fee Structure of the respective grade. All other applicable fees are payable.
3. After availing of the scholarship, if all the applicable fees are paid as a one-time down payment, an additional rebate of 6% will be awarded on the discounted annual tuition fee payable.
4. An application will have to be submitted in the prescribed format available with the school, along with all the relevant supporting documents.
5. All decisions for the grant of scholarships are at the sole discretion of the management, and no representation will be accepted.
6. Intimation of scholarship approval will be made in writing, duly signed by the management representative. No oral confirmation will be considered.
7. The scholarship is valid only for one academic year. The scholarship amount will be adjusted only against the last fee instalment(s) as per the fee structure.
8. Scholarship for ISC (Class XII) will be based on the performance in the Board Exams. (Grade 12). A fresh application with relevant supporting documents will have to be submitted for the scholarship after the declaration and receipt of the Board Results. Accordingly, the scholarship amount will be reimbursed.
9. The management at any time may withdraw the scholarships offered without any prior notice.
